Notification

In super-session of the Government Notifications No. 49/32/2000/1IB (1) dated 12th May, 2000; No. SIT/162/2006/4 dated 28th July, 2000 and No. 2/17/2000/2SIT dated 19th July, 2005, the Governor of Haryana is pleased to reconstitute the State Level Steering Committee - IT PRISM (P=planning, R= Re-engineering, I= Implementation, S= Steering and M= Monitoring) to oversee computerization and application of Information Technology in the state of Haryana.

2. The constitution of the Committee shall be as follows:

3. The role and functions of the Committee shall be as under:-

- (i) To provide Policy directions and oversee the State e-Governance Programmes under the NeGP;
- (ii) To oversee the computerization and application of Information Technology in the State. This includes finalization of Business models; outsourcing, approval of mid course changes, approval of the financials necessitated on account of mid courses corrections/ Changes Requests

and other related activities of IT Projects funded by State/ Central Government;

- (iii) To determine the sectoral priorities for computerization;
 - (iv) To review the progress of implementation of IT Action Plans of various Government Departments, Boards and Corporations/ Organisations;
 - (v) To approve budget, posts and expenditure for IT Projects;
 - (vi) To devise the ways and means for the promotion of IT Education in Haryana;
 - (vii) To review the ROW Policy of the State keeping in view the guidelines/ directions issued by Department of Telecommunication/ Department of Electronics & Information Technology, Government of India from time to time;
 - (viii) The Committee will also act as the State Level Apex Committee for implementation of e-District Project, e-Disha Project and CSC Scheme.
4. The approval of any proposal by this committee shall be deemed to be final and no further reference will be required to be made to the AD/FD as per amendment in the Rule of Business of Government of Haryana, 1977 issued vide Notification No. 10/13-2 cabinet 2000 dated 25th September, 2000.
5. The Headquarters of the Committee shall be at Chandigarh.
6. The Committee will meet at least once in a quarter or as and when required.
7. TA/DA shall be drawn by the members from their respective Departments.
8. Non official members shall be entitled to draw such remuneration and travelling and other allowances as may be specified by the Steering Committee.
