3. The roll and functions of the Committee shall be as under:-


- (i) To provide policy directions and oversee the State e-Governance Programme under the Digital India Project.
- (ii) To resolve inter- ministerial issues under the project.
- (iii) To harmonize and integrate diverse initiatives and aspects related to integration of services, end to end process re-engineering and service levels of MMPs and other initiatives under the Digital India Programme.
- (iv) The Headquarter of Committee shall be at Chandigarh.
- (v) The committee will meet as and when required.
- (vi) TA/DA, if any, by the members shall be drawn from their respective departments.
